The YouthReach Initiative

Program: The YouthReach Initiative makes grants to arts organizations and other community groups to support in-depth arts programs for young people in need. Launched in 1994, YouthReach now supports 38 partnerships in communities across Massachusetts

Funds:

- ✓ Organizations that have not received funding previously may request up to \$22,000 per year for two years.
- ✓ Second-cycle applicants (those which gave already received two years of YouthReach funding) may request up to \$25,000 per year for two years.
- ✓ Third-cycle applicants (those which gave already received four years of YouthReach funding) may request up to \$20,000 per year for two years.
- ✓ Fourth-cycle applicant and beyond (those which gave already received six years of YouthReach funding) may request up to \$15,000 per year for two years.

- ✓ Investing in Youth: Including but not limited to enabling youth to advocate and organize on their own behalf on issues affecting them, including violence, bias, substance abuse, and economic self sufficiency; parent leadership development; and organizing focused on improving public education.
- ✓ Assisting New Americans: Efforts focused on enabling new American communities to assert their rights to fair, just and humane treatment. Including but not limited to: community-based education; leadership training and organizing campaigns that advocate for decent working conditions; and fight punitive provisions in anti-immigrant initiatives and legislation.
- ✓ Women in Poverty/Purim Fund: Combating the "feminization of poverty" through organizing by and for women on the special challenges women face in getting out of poverty.
 - Jewish Social Justice Groups: Encouraging local Jewish social justice activism.
