COMMITTEE HEARING NOTICE

The Boston City Council's Committee on Public Safety will hold a public on **Tuesday, May 24, 2011 at 3:00 PM** in the **Iannella Chambers on the fifth floor of the Boston City Hall.**

The subject of the hearing is:

Docket # 0382 Message and order authorizing the Fire Department to accept and expend a grant of \$25,000.00 from the Massachusetts Executive Office of Health & Human Services, for deploying, maintaining and implementing 10 Massachusetts Decontamination Units.

Docket # 0469 Message and order authorizing the Mayor's Office of Emergency Management to accept and expend a grant of \$299,725.00 from the DHS, PSCP Grant FY2011, to provide standardized equipment for the City's dive teams that will lead to a coordinated dive capability with a Level I FEMA certificate.

Docket # 0470 Message and order authorizing the Mayor's Office of Emergency Management to accept and expend a grant of \$150,000.00 from the DHS, EMPG, to provide resources to assist local governments to sustain and enhance all-hazards emergency management capabilities.

Docket # 0498 Message and order authorizing the Mayor's Office of Emergency Management to accept and expend a grant \$15,147,184.00 from the DHS, Urban Area Security Initiative UASI Grant 2010, to support unique planning, exercise, training and operational needs of large urban areas.

Docket # 0499 Message and order authorizing the Mayor's Office of Emergency Management to accept and expend a grant of 3,462,900.00 from the DHS, Regional Catastrophic preparedness Grant program Grant FY2010, for the purpose of catastrophic planning with designated region, including the Boston Urban Area.

Docket # 0578 Message and order authorizing the Police Commissioner to accept and expend the Fy12 State 911 Department PSAP and Regional Emergency Communication Center Support and Incentive grant of \$2,409,212.00 from the Executive Office of Public Safety and Security State 911 Department.

Docket #0682 Message and order authorizing the Police Commissioner to accept and expend additional funds of Forty-Forty Thousand, One Hundred and nine dollars (\$44,109.00) from the Massachusetts Department of Mental Health under a second FY2011-FY2012 Jail Division Program Grant.

This matter was sponsored by Mayor Menino and referred to the committee on 3/23/11.
