ADMINISTRATIVE REVIEW

In order to expedite the review process, the Commission has delegated the approval of certain work items, such as those involving ordinary maintenance and repair, restoration or replacement, or which otherwise have a minimal impact on a building's appearance, to the staff pending ratification at its monthly public hearing. The following applications have been identified as being eligible for such approval.

► *Applicants listed under this heading **NEED NOT APPEAR** at the hearing. Following the hearing, please present this agenda at the Inspectional Services Department (1010 Massachusetts Avenue) when applying for permits. ISD personnel will send a facsimile of your building-permit application to the Environment Department. Upon its receipt Commission staff will sign off on the work, attaching any applicable provisos, reflecting the relevant guidelines and precedents.*

***PLEASE NOTE** that no further correspondence will be issued for the applications listed below: the building-permit application as annotated by Commission staff will constitute your Certificate of Appropriateness.*

11.712 SE: Worcester Square: In kind replacement of one 50-inch high by 53-inch long panel of the fencing around Worcester Square park. The existing steel fence with galvanized color coating was installed in 1984. The panel needing replacement was damaged by an automobile in January 2011.

11.724 SE: 17-21 Worcester Square: Repair and repaint brownstone stoop at 17-19 Worcester Square. Replace badly-broken bluestone slab at coal bunker, in kind.

11.726 SE: 162 West Canton Street: Replace aluminum 6/6 and 9/9 windows with wood 2/2 windows, with trapezoidal profile muntins.

11.728 SE: 203 West Springfield Street: Replace aluminum gutter with copper gutter. Gutter is at rear of building, facing the Worcester Street Garden.

11.730 SE: 113 Pembroke Street: Replace 6/6 and 9/9 windows with wood 2/2 windows, with trapezoidal profile muntins. Install half screens.

11.732 SE: 682 Tremont Street: Replace fabric on existing storefront canopy framework, with new lettering on valance.

11.733 SE: 492 Massachusetts Avenue: Repoint all elevations. Repair and repaint copper bays.

11.737 SE: 74 Union Park Street (Cathedral High School): Install 45 wood replacement windows, part of a phased window replacement project that was initiated in 2007 to correct a window violation condition. The 45 windows in this phase match what were approved in the 2008, 2009 and 2010 phases.
