ADMINISTRATIVE REVIEW

In order to expedite the review process, the Commission has delegated the approval of certain work items, such as those involving ordinary maintenance and repair, restoration or replacement, or which otherwise have a minimal impact on a building's appearance, to the staff pending ratification at its monthly public hearing. The following applications have been identified as being eligible for such approval.

► Applicants listed under this heading **NEED NOT APPEAR** at the hearing. Following the hearing, please present this agenda at the Inspectional Services Department (1010 Massachusetts Avenue) when applying for permits. ISD personnel will send a facsimile of your building-permit application to the Environment Department. Upon its receipt Commission staff will sign off on the work, attaching any applicable provisos, reflecting the relevant guidelines and precedents.

PLEASE NOTE that no further correspondence will be issued for the applications listed below: the building-permit application as annotated by Commission staff will constitute your Certificate of Appropriateness.

11.741 SE: 27 East Concord Street: Replace deteriorated slates on mansard in kind. Replace rotted fascia and trim in kind. Replace gutters and downspouts with copper.

11.781 SE: 195 West Brookline Street: Install concrete slab to stabilize coal bunker, install waterproof membrane and reset existing cracked bluestone slab. Patch slab to match and install new bronze coal cap to replace cracked cap. Reset the second, smaller bluestone slab and its metal cap.

11.802 SE: 46-51 San Juan Street: Repoint. Temporarily remove brick above lintels, install flashing and reset existing bricks. Apply sealant around lintels and sills, with color and texture to match pointing mortar.

11.804 SE: 90 Worcester Street: Replace asphalt shingles on front mansard. Replace slates on rear mansard (not visible from public way) with asphalt shingles.

11.814 SE: 598 Tremont Street: Repair front stoop and walkway to match existing design, color and texture.

11.815 SE: 29 Braddock Park: Replace 14 vinyl windows with 2/2 wood exterior windows, with the exception of the narrow flanking windows in the bay, which will be 1/1.

11.816 SE: 1762 Washington Street: Install new signage in existing blade sign.

11.817 SE: 456 Shawmut Avenue: Repoint chimney, install steel chimney cap.

11.818 SE: 37 Upton Street: Repoint. Repair lintels and sills as needed to match existing profile, color and texture.

11.819 SE: 1313 Washington Street: Install new signage in existing blade sign. Install vinyl lettering on storefront windows.

11.820 SE: 35 Rutland Square: Repaint lintels, sills and masonry trim Benjamin Moore color HC-69. Repaint window grilles black.

11.821 SE: 62 Rutland Square: Replace 4 vinyl windows at attic dormer with aluminum clad 2/2 and 1/1 windows. Replace aluminum gutters with copper ones. Replace deteriorated slate roof in kind. Install copper drip edge. Repoint masonry.
