FY12 WAYS & MEANS BUDGET HEARING NOTICE

April 21, 2011

The Boston City Council's Committee on Ways & Means will hold public hearings according to the attached schedule. All hearings will be held in the Christopher A. Iannella Chamber on the 5th floor of the Boston City Hall.

Docket # 0534 Message and order approving an appropriation of \$35,000,000.00 (Thirty Five Million Dollars) to the Other Post Employment Benefits (OPEB) Liability Trust Fund established under Section 20 of the Massachusetts General Law Chapter 32B.

- Docket # 0543** Message and order for a loan of Six Million Nine Hundred Seventy Thousand Dollars (\$6,970,000.00), for constructing or reconstructing bridges of stone or concrete or of iron superstructure, for the original construction of public ways or the extension or widening thereof, including land damages and the cost of pavement and sidewalks laid at the time of said construction, or for the construction of stone, block, brick, cement concrete, bituminous, concrete, bituminous macadam or other permanent pavement of similar lasting character, and/or for macadam pavements or other road material, or for the resurfacing with such pavement or other road material of municipally owned or operated off-street parking areas; and/ or for the cost of departmental equipment; and/or for the cost of engineering or architectural services for plans and specifications for the purposes of city departments including the Public Health Commission, Public Works and Transportation Department.
