The Boston City Council Committee on Public Safety will hold a hearing on Monday, March 19, 2012 at 3:30 PM in the Iannella Chamber on the 5th Floor of the Boston City Hall.

The subject of the hearing is:

Docket # 0276 - Message and order authorizing the Fire Commissioner to accept and expend a grant of \$67,500.00 from the Mass Executive Office of Public Safety and Security, for the purpose of funding the BPD FY10 Buffer Zone Protection Project (Park Plaza Hotel).

- Docket # 0277 - Message and order authorizing the Fire Commissioner to accept and expend a grant of \$51,096.00 from the Mass Executive Office of Public Safety and Security, for the purpose of funding the BFD FY10 Buffer Zone Protection Program for its portion of the FY10 BZPP and Vulnerability Reduction Purchasing Plan for the Markley Group BZOO site.

Docket # 0278 -- Message and order authorizing the Fire Department to accept and expend a grant of \$20,000.00 from the Massachusetts Executive Office of Health and Human Services, Department of Public Health for FY12, for the purpose of deploying, maintaining and implementing 10 Mass Decontamination Units.

Docket # 0300 - Message and order authorizing the Fire Department to accept and expend a Port Security Program Grant of \$81,168.07 from the Commonwealth of Massachusetts Executive Office of Public Safety and Security, for the Underwater Devices Training.
