In order to expedite the review process, the Commission has delegated the approval of certain work items, such as those involving ordinary maintenance and repair, restoration or replacement, or which otherwise have a minimal impact on a building's appearance, to the staff pending ratification at its monthly public hearing. The following applications have been identified as being eligible for such approval.

ISD personnel will send a facsimile of your building-permit application to the Environment Department. Upon its receipt Commission staff will sign off on the work, attaching any applicable provisos, reflecting the relevant guidelines and precedents.

PLEASE NOTE that no further correspondence will be issued for the applications listed below: the building-permit application as annotated by Commission staff will constitute your Certificate of Appropriateness.

- 12.237 BH: 66 Beacon Street: Repaint window sash to match existing color and finish.
- 12.236 BH: 86A Beacon Street: Repoint rear chimney, remove and replace individual cracked/spalled bricks at fire escape supports and chimney.
- 12.230 BH: 71 Brimmer Street: Remove and replace in-kind sidewalk pavers and granite curb.
- 12.233 BH: 141 Cambridge Street: Conserve and restore 8 window sash, 5 located on e. elevation, 1st fl. and 3 on w. elevation 1st fl. Install low profile snow guards on slate roof (e. elevation).
- 12.234 BH: 100 Charles Street: Replace 4 windows on 4th floor. 2 on front and 2 on rear with wood 2/2 sash, 7/8" muntins.
- 12.231 BH: 3,4,5 Joy Street: Paint front doors and paint front railings to match existing color and finish.
- 12.232 BH: 65 Mount Vernon Street: Replace existing deteriorated double hung windows on 1st floor with single-hung wood windows with 1/1 sash, clear insulated glass.
- 12.238 BH: 93 Mount Vernon Street: Replace missing shutter to match existing.
- 12.225 BH: 50 Myrtle Street: Install "No Smoking" sign next to adjacent signage.
- 12.226 BH: 21 Phillips Street: Install "No Smoking" sign next to adjacent signage.
- 12.222 BH: 40 Phillips Street: Repoint front elevation; install new copper perimeter edge flashing in kind.
- 12.224 BH: 87 Pinckney Street: Repoint brick wall facing Myrtle Street.
- 12.223 BH: 89 Pinckney Street: Repoint brick wall facing Myrtle Street.
- 12.221 BH: 20 West Cedar Street: Replace 2 basement windows with wood true divided lite 6/6 sash, 7/8" muntins.
