The Boston City Council's Committee on Public Safety Committee will hold a hearing on **Thursday, December 15, 2011 at 11:00 AM** in the Iannella Chamber on the fifth floor of the Boston City Hall.

The subject of the hearing is:

**Docket # 1526** – Message and order authorizing the Police Commissioner to accept and expend a grant of One Million Four Hundred Sixty Three Thousand Dollars (\$1,463,000.00) from the Massachusetts Executive Office of Public Safety and Security Senator Charles E. Shannon Jr. Community Safety Initiative Grant, for the purpose of supporting strategies to address youth, gang and gun violence.

**Docket # 1528** – Message and order re-authorizing the Boston Fire Academy to establish again a revolving fund to support training programs for firefighters from non-City of Boston Fire Departments, accordance with the M.G.L. Chapter 44, Section 531/2 in the amount of Two Hundred Thousand Dollars (\$200,000.00) for the purpose of purchasing training equipment, certifying instructors fees, updating facilities and providing funds for other trainings.

**Docket # 1531** – Message and order authorizing the Police Commissioner to accept and expend a grant in the amount of Five Thousand Four Hundred Dollars (\$5,400.00) from the FY11 NIJ Social Sciences Research in Forensic Science, passed through from the University of Illinois-Champaign, to support analysis, data collection and reporting by the BPD's Crime Lab and Office of Research and Development.
