The subject of the hearing is:

**Docket #0903-Message and order authorizing the Superintendent of the Boston Public Schools, pursuant to G.L. c44, Sec 53E 1/2, to establish a revolving fund which shall be credited with any and all receipts in FY2013 from subsidized Field Trips for Boston Public Schools Transportation. Receipts and resulting expenditures from this fund for FY2013 shall not to exceed \$125,000.00.**

**Docket #0904-Message and order authorizing the Superintendent of the Boston Public Schools, pursuant to G.L. c44 Sec 53E 1/2, to establish a revolving fund which shall be credited with any and all receipts in FY13 from lease, permit for use, and parking fees for Boston Public Facilities. Receipts and resulting expenditures from this fund for Fiscal Year 2013 shall not exceed \$1,800,000.00.**

**Docket #0905-Message and order authorizing the Superintendent of the Boston Public Schools, pursuant to G.L. c44, Sec. 53E 1/2, to establish a revolving fund to which shall be credited with any and all receipts in FY13 from equipment sales and repair fees for the Boston Public Schools Technology. Receipts and resulting expenditure from this fund for Fiscal Year 2013 shall not exceed \$1,500,000.00**
