COMMITTEE HEARING NOTICE

The Boston City Council's Committee on **Ways and Means** will hold a public hearing on Monday, August 20, 2012 at **1:00PM** in the **Iannella Chamber**.

The subject of the hearing is:

#1034, Message and order approving a supplemental appropriation of Nine Thousand Five Hundred Dollars (\$9,535) for Property and Construction Management Department to cover FY13 cost items contained within the collective bargaining agreement between the City of Boston and the National Conference of Firemen and Oilers (NCFO). The terms of the contracts are July 1, 2012 through June 30, 2013 through June 30, 2016. The major provision of the contracts include base wage increases of 1%, 2%, 3%, 3% and 3% to be given in october of each fiscal year from July 1, 2011 through June 30, 2016. There is not base wage increase in Fiscal year 2011.

#1035 Message and order to reduce the FY13 appropriation for the Reserve for Collective Bargaining by Nine Thousand Five Hundred Dollars (\$9,535.00) to provide funding for the Property & Construction Management Department to cover FY13 salary increases contained within the collective bargaining agreements between the City of Boston and the National Conference of Firemen and Oilers (NCFO).

This matter was sponsored by Mayor and referred to the committee on 8/1/12.
