The subject of the hearing is:

***Docket # 1036 – Message and order to declare surplus of a portion of Franklin Street, Brighton, [approximately 3,677 + sq. ft.] from Braintree Street, which is shown on a plan of land entitled “City of Boston, Public Works Department, Engineering Division – Discontinuance Plan, 27A Lawrence Street, Boston - to convey the said portion area by a Release Deed in form satisfactory to the Corporation Counsel, to certain abutters.***

This matter was sponsored by Mayor Menino and referred to the committee on August 1, 2012.
