COMMITTEE HEARING NOTICE

December 7, 2012

The Boston City Council's Committee on Public Safety will hold a public hearing on **Tuesday, December 11, 2012 at 2:30 PM** in the **Iannella Chambers on the fifth floor of the Boston City Hall.**

The subject of the hearing is:

Docket #1328 Message and order authorizing the Police Commissioner to accept and expend the FY12 (VAWA) STOP grant of \$42,400.00 from the Executive office of Public Safety and Security used to support the BPD Civilian Domestic Violence Advocate.

Docket #1587 Message and order authorizing the City to accept and expend a grant of \$3,000,000.00 from the U.S. Department of Homeland Security, FFY10 Transit Grant Program Award, passed through the MBTA.

Docket #1590 Message and order authorizing the Police Commissioner to accept and expend a grant of \$125,000.00 for the FY 2012 Demonstration Programs Continuation from the Office of Juvenile Justice and Delinquency Prevention used to support the development and enhancement of the Youth Violence Prevention Plan.

Docket #1633 Message and order authorizing the Police Commissioner to accept and expend a grant of One Million Four Hundred Eighty One Thousand, Six Hundred Ninety Seven Dollars and Forty Two cents (\$1,481,697.42) from the Massachusetts Executive Office of Public Safety FY 2013 Senator Charles E. Shannon Jr. Community Safety Initiative Grant, for the purpose of supporting strategies to address youth, gang and gun violence.

Docket #1635 Message and order authorizing the Police Department to accept and expend the FY 2012 Traffic Enforcement grant funds of Fifteen Thousand Dollars (\$15,000.00) from the Massachusetts Executive Office of Public Safety and Security Highway Safety Division.

These matters were sponsored by Mayor Menino and referred to the committee on 11/28/12 and 12/3/12.
