**88 Pinckney Street:** Construction of rooftop structures that are visible from a public way, without prior review or approval.

**144 Charles Street/Charles Street Garage:** Placement of a telecommunications antenna on a chimney that is not in keeping with the conditions set by the BHAC at its November 18, 2010 public hearing. Installation of an antenna or alarm device on the south elevation of the building where the three-story section adjoins the four-story section, without prior review or approval.

**99 Revere Street:** Installation of windows that do not meet the Historic Beacon Hill District Architectural Guidelines.

## ADMINISTRATIVE REVIEW / APPROVAL

*In order to expedite the review process, the Commission has delegated the approval of certain work items, such as those involving ordinary maintenance and repair, restoration or replacement, or which otherwise have a minimal impact on a building's appearance, to staff pending ratification at the Commission's monthly public hearing. Having been identified as meeting these eligibility criteria, the following applications will be approved at this hearing:*

► Applicants listed under this heading **NEED NOT APPEAR** at the hearing. Following the hearing, please present a copy of this agenda at the Inspectional Services Department (1010 Massachusetts Avenue) when applying for permits. ISD personnel will send an electronic copy of your building-permit application to the Environment Department. (To avoid potential confusion, the text of your building-permit application should be consistent with the project description given below.) Commission staff will accordingly authorize the execution of the work, attaching any applicable provisos, reflecting the relevant guidelines and precedents.

**PLEASE NOTE THAT NO FURTHER CORRESPONDENCE WILL BE ISSUED** for the applications listed below: the electronic building-permit application as annotated by commission staff will constitute your Certificate of Appropriateness.

Items below are listed in alphabetical order, by street name

- 13.612 BH:**      **15 Beacon Street:** Repair broken masonry at herringbone-pattern band, including localized repointing, all work to match historic fabric.
- 13.695 BH:**      **33 Beacon Street:** Replace slates on carriage house, reusing salvageable slates and replacing damaged ones in kind.
- 13.696 BH:**      **45 Beacon Street:** Temporarily remove, restore and reinstall deteriorated window sash.
- 13.697 BH:**      **13 Charles Street:** Remove air conditioning unit from transom and restore its 9-pane configuration.
- 13.698 BH:**      **5 Chestnut Street:** Replace two wood window boxes in-kind, to be painted to match existing color.
- 13.699 BH:**      **67 Mount Vernon Street:** Wash the front steps, the front walkway and the stone posts at the public sidewalk.
- 13.700 BH:**      **3 Myrtle Street:** Replace deteriorated slates with matching slates. Replace flashing, copper gutters and downspouts. Flash and repair chimneys with caps.
- 13.701 BH:**      **19 Myrtle Street:** Replace all second story wood 1/1 windows in kind. Repaint to match existing color, Benjamin Moore Essex Green.
- 13.702 BH:**      **61 Phillips Street:** Replace three wood 1/1 windows with new wood 1/1 windows. Replace three windows at rear (exempt).
- 13.620 BH:**      **37 Revere Street:** Repair damaged stucco band at top of first story.
- 13.703 BH:**      **52 Revere Street:** Repair lintels and sills. Repoint. Repair entry, including removal of defunct buzzer panels.
- 13.704 BH:**      **23 West Cedar Street:** Replace one wood 3/3 window at basement level in kind and paint it black. Paint main door either Benjamin Moore Historical Color Van Deusen Blue #156 or Phillipsburg Blue #159.
