The Boston City Council's Committee on Ways and Means will hold a public hearing on **Thursday, April 4, 2013 at 10:00 AM** in the **Iannella Chamber**.

The subject of the hearing is:

- #0499** Message and order to reduce the appropriation for the Reserve for Collective Bargaining by Three Hundred-Ninety Six Thousand Fifty Five Dollars (\$396,055.00) to provide funding for the Boston Public Health Commission (BPHC) for the FY13 salary increases contained within the collective bargaining agreements between the Boston Public Health Commission and the American Federation of States, County, and Municipal Employees (AFSCME), Council 93, Local 787 as well as the cost of salary increases for non-union BPHC employees.
- #0500** Message and order approving a supplemental appropriation of Three Hundred Ninety-Six Thousand Fifty Dollars (\$396,055.00) for the Boston Public Health Commission for FY13, to cover cost items contained within the collective bargaining agreements between the Boston Public Health Commission (BPHC) and the American Federation of States, County, and Municipal Employees (AFSCME), Council 93, Local 787 as well as the cost of salary increases for non-union BPHC employees.

This matter was sponsored by Mayor and referred to the committee on March 27, 2013.
