The Boston City Council's Committee on Public Safety will hold a public hearing on **Friday, July 26, 2013 at 4:00 PM** in the **Iannella Chambers on the fifth floor of the Boston City Hall.**

The subject of the hearing is:

Docket 0989 - Message and order authorizing the City of Boston to accept and expend the FY 14 State 911 Department PSAP and Regional Emergency Communication Center Support and Incentive Grant Program funds in the amount of Two Million Seven Hundred Eight Thousand, Three Hundred Thirty Four Dollars (\$2,708,334.00) awarded by the Massachusetts Executive Office of Public Safety and Security's State 911 Department.

Docket 0990 Message and order authorizing the City of Boston to accept and expend the FY 14 State 911 Department Training Grant funds in the amount of Six Hundred Sixty Thousand, Two Hundred Sixty-Two Dollars (\$660,262.00) awarded by the Massachusetts Executive Office of Public Safety and Security's State 911 Department.

Docket 0991- Message and order authorizing the Boston Police Department to accept and expend the grants to encourage arrest policies and enforcement of protections Orders grants awarded by the U.S. Department of Justice, Office on violence against women for the Boston Multi-Disciplines advocates support project in the amount of Six Hundred Fifty Thousand Dollars. (\$650,000.00)

Docket 0992 Message and order authorizing the City of Boston to accept and expend a grant in the amount of Three Hundred Eleven Thousand Eight Hundred Nine Dollars (\$311,809.00) from the U.S. Department of Justice, Office of Justice Programs.

Docket 1086 – Message and order authorizing Police Commissioner to accept and expend a grant of One Hundred Nineteen Thousand Dollars (\$119,000.00) from the Massachusetts Department of Mental Health under the second FY13 Jail Diversion Program Grant for the purpose of providing assistance and referrals in individuals with Mental Illness and Emotional disturbance.

These matters were sponsored by Mayor Menino and referred to the committee on 6/12/13.
