The subject of the hearing is:

**Docket # 1396** - Message and order authorizing the Mayor's Office of Emergency Management to accept and expend a grant of Fourteen Million Fifty-One Thousand Seven Hundred Fifty Dollars (\$14,051,750.00) from the U.S. Department of Homeland Security, Urban Area Security Initiative Grant FFY2013, address the unique planning, training, exercise equipment, and operational needs of large urban areas, and assist them in building and enhancing and sustainable capacity to prevent, respond to and recover from threats of acts of terrorism, including chemical, biological, radiological, nuclear and explosive incidents.

This matter was sponsored by Mayor Menino and referred to the committee on 9/11/13.
