Docket #0302 - Message and order to reduce the FY14 appropriation for reserve for Collective Bargaining by Five Hundred Forty Eight Thousand Eighty-One Dollars (\$548,081.00) to provide funding for the Boston Public Schools for FY14 cost contained within the collective bargaining agreements between the Boston School Committee and the Administrative Guild, SEIU Local 888.

Docket #0303 - Message and order approving a supplemental appropriation of Five Hundred Forty Eight Thousand Eighty-One Dollars (\$548,081.00) for the Boston Public Schools for FY14 to cover cost items contained within the collective bargaining agreements between the Boston School Committees and the Administrative Guild, SEIU Local 888.
