## COMMITTEE HEARING NOTICE

April 15, 2014

The Boston City Council's Committee on Ways and Means will hold a public hearing on Thursday, May 15, 2014 at 11:00AM. This revolving fund hearing will be run concurrent with relevant FY15 operating budget and capital budget hearings. All hearings will be held in the Christopher A. Iannella Chamber.

The subject of the hearings include:

- 0668 Message and order authorizing the Boston Fire Academy to re-establish in accordance with General Law Chapter 44, Section 53E ½ a revolving fund to accept from the fund up to a maximum of One Hundred Thousand Dollars (\$100,000.00) to fund Fiscal Year 2015 to support training programs for firefighters from non-City of Boston fire agencies. The Academy will charge participating outside agencies tuition for each firefighter recruit they send to the Academy.
- 0669 Message and order authorizing the Boston Fire Department to re-establish in accordance with General Law Chapter 44, Section 53E ½ a revolving fund to accept from the fund up to a maximum of One Hundred Thousand Dollars (\$100,000.00) to fund Fiscal Year 2015 to support Boston Fire Department's participation in the detection, cleanup and containment of hazardous material release.
- 0672 Message and order authorizing the Boston Fire Department Academy to re-establish in accordance with General Law Chapter 44, Section 53E ½ a revolving fund to accept from the fund up to a maximum of Twenty Five Thousand Dollars (\$25,000.00) to fund Fiscal Year 2015 to support paying employee's related cost.
