The Boston City Council's Committee on Ways and Means will hold a public hearing on Tuesday, June 3, 2014 at 3:30PM in the Iannella Chamber, 5th Floor, Boston City Hall.

The subject of the hearing is:

- 0919 Message and order to reduce the FY14 Appropriation for the Reserve for Collective Bargaining by Twelve Million Five Hundred Nineteen Thousand Five Hundred Eighty Seven Dollars (\$12,519,587.00) to provide funding for the Fire Department for the FY14 cost contained in the collective bargaining agreements between the City of Boston and Boston Firefighters Association, IAFF, Local 718, AFL-CIO-CIC (Units A and B).
- 0920 Message and order approving a supplemental appropriations of Twelve Million Five Hundred Nineteen Thousand Five hundred Eighty-Seven Dollars (\$12,519,587.00) to provide funding for the Fire Department for the FY14 cost contained in the collective bargaining agreements between the City of Boston and the Boston Firefighters Association, IAFF, Local 718, AFL-CIO-CLC (Units A and B).
