## COMMITTEE HEARING NOTICE

The Boston City Council's **Committee on Healthy Women, Families and Communities** will hold a public hearing on Tuesday, June 24, 2014 at 9:00 a.m. in the Christopher Iannella A. Chamber.

The subjects of the hearing are:

**Docket #0586-Message and order authorizing the Boston Centers for Youth and Families to accept and expend a grant of Thirty-One-Thousand Dollars (\$31,000.00) from the Boston Public Health Commission for the purpose of continued support for the Safe and Successful Youth Initiative.**

**Docket #0921-Message and order authorizing the Office of Youth Engagement & Employment to accept and expend a grant of Seven Hundred Fifty Thousand Dollars (\$750,000.00) from individuals, organizations, and local and private businesses for the purpose of supporting year-round youth employment.**

These matters were sponsored by Mayor Martin S. Walsh and referred to the committee on April 4, and May 21, 2014 respectively.
