The Boston City Council's Committee on Healthy Women, Families and Communities will hold a public hearing on Tuesday, September 2, 2014 at 1:00PM in the Piemonte Room, fifth floor, Boston City Hall.

**DOCKET 1226:** *Message and Order authorizing the Commission on Affairs of the Elderly to apply for, accept and expend renewal grant of Sixteen Million Dollars (\$16,000,000.00) from the Massachusetts Executive Office of Elder Affairs, for the continued operation of the Region VI Area Agency on Aging (AAA) and Direct Service grant.*

**DOCKET 1227:** *Message and Order authorizing the Commission on Affairs of the Elderly to apply for, accept and expend renewal grant of Four Million Dollars (\$4,000,000.00) from the Massachusetts Executive Office of Elder Affairs, for the continued operation of the State Elder Lunch Program.*

**DOCKET 1229:** *Message and Order authorizing the Commission on Affairs of the Elderly to apply for, accept and expend renewal grant of Two Million Seven Hundred Thousand Dollars (\$2,700,000.00) from the Massachusetts Executive Office of Elder Affairs, for the continued operation of the Nutrition Services Incentive Program.*

**DOCKET 1230:** *Message and Order authorizing the Commission on Affairs of the Elderly to apply for, accept and expend renewal grant of One Million Dollars (\$1,000,000.00), under the Domestic Volunteer Service Act of 1973, from the federal volunteer agency, for the continued operation of the Commission's Senior Companion Program in the City.*

**DOCKET 1231:** *Message and Order authorizing the Commission on Affairs of the Elderly to apply for, accept and expend renewal grant of Six Hundred Fifty Thousand (\$650,000.00), from the federal volunteer agency, for the continued operation of the Commission's Retired Senior Volunteers Program in the City.*
