**Docket #1492-Message and order to reduce the FY15 appropriation for reserve for Collective Bargaining by Two Million Two Hundred and Nine Hundred and Forty One Dollars (\$2,209,941.00) to provide funding for the Boston Public Health Commission for the FY15 salary increases contained within the collective bargaining agreement between the Boston Public Health Commission and the Boston EMS Division of the Boston Police Patrolmen's Association.**

**Docket #1493-Message and order approving a supplemental appropriation of Two Million Two Hundred and Nine Hundred and Forty One Dollars (\$2,209,941.00) for the Boston Public Health Commission (BPHC) for FY15 cost items contained within the Collective bargaining agreement between the Boston Public Health Commission and the Boston EMS Division of the Boston Police Patrolmen's Association.**
