- 0340** Message and order authorizing the City of Boston to accept and expend a capital contribution in an amount not to exceed One Million Two Hundred Eighty Thousand Dollars (\$1,280,000.00) from the Boston Redevelopment Authority (BRA) in support of the Connect Historic Boston Initiative. This capital grant contribution is being awarded to the City of Boston through the Public Works Department in the capacity of development mitigation funds which will be used to assist with the reconstruction of Causeway Street in Boston as a part of the Connect Historic Boston Initiative.
