COMMITTEE HEARING NOTICE

October 1, 2015

The Boston City Council's Committee on Public Safety will hold a public hearing on **Monday, November 9, 2015 at 10:30AM** in the **Christopher A. Iannella Chamber**, 5th Floor, Boston City Hall.

The subject of the hearing is:

- 1590 Message and order authorizing the Fire Commissioner to accept and expend a grant of One Million Seven Hundred Fifty Thousand Dollars (\$1,750,000.00) from the Commonwealth of Massachusetts Executive Office of Public Safety and Security, Department of Fire Services, for the Boston Fire Department Training Division.
- 1591 Message and order authorizing the Police Commissioner to accept and expend a grant of Two Hundred Fifty-Two Thousand Sixty-Two Dollars (\$252,062.00) from the office from the Office of Juvenile Justice Delinquency Prevention (OJJDP) used to support the development of enhancement of Youth Violence Prevention Plan.
- 1592 Message and order authorizing the Fire Commissioner to accept and expend a grant of Two Hundred Thirty Seven Thousand Five Hundred Dollars (\$237,500.00) from the Commonwealth of Massachusetts, Executive Office of Public Safety and Security, Department of Fire Services for the Boston Fire Department Hazmat Division. This award is made for the sole purpose of supplementing City appropriations to maintain hazmat materials response team operations.
- 1593 Message and order authorizing the Police Commissioner to accept and expend supplemental funding of Seventy Thousand Dollars and Twelve Cents (\$70,000.12) for the FY11 & FY14 Community-based Violence Prevention Demonstration Project grant, from the Office of Juvenile Justice and Delinquency Prevention (OJJDP) which will be used to implement evidence based strategies that will positively impact violent crime trends.

These matters were sponsored by Mayor Martin J. Walsh and referred to the committee on September 30, 2015.

Members of the public are cordially invited to attend and testify. If you have not testified at a Council hearing before, please arrive (5) minutes before the call of the hearing to sign up and become familiar with the hearing format, testimony locations, and sound system. Please bring fifteen (15) copies of any written documentation you wish to present at the hearing. If you know of others who may be interested in this hearing, kindly notify them.

Written comments may be made part of the record and available to all Councilors by sending them by email, fax, or mail to arrive before the hearing, please use the information below.
