The Boston City Council's Committee on Government Operations will hold a public hearing on **Thursday, December 3, 2015 from 10:00 AM to 3:00 PM**. The hearing will be held in the Christopher A. Iannella Chamber on the Fifth Floor of Boston City Hall. The subject matters of the hearing are:

**Docket #0184, ordinance mandating use of automated external defibrillators on Boston Police vehicles responding to 911 calls in the City of Boston;**

**Docket #0188, an ordinance calling for mandatory use of GPS technology on all emergency vehicles operating in the City of Boston;**

**Docket #0183, ordinance amending CBC 6-2.5, elderly property tax exemption; and,**

**Docket #0182, ordinance amending the Minority and Women Business Enterprise Ordinance.**

These matters were sponsored by Councilor Charles Yancey and were referred to the Committee on Government Operations on January 14, 2015.
