Public Hearing Continued

1. On a petition by 160 Federal Street Property LLC for the making of **Specific Repairs** within the following public ways in Boston Proper, consisting of new decorative bronze inlays: (NB 3/3/2016, PH 3/17/2016)

- **Federal Street** – on its easterly side north of High Street.
- **High Street** – on its northwesterly side east of Federal Street.
