


## NOTICE OF PUBLIC HEARING

NOTICE OF PUBLIC HEARING TO BE HELD BY MASSACHUSETTS  
DEVELOPMENT FINANCE AGENCY CONCERNING THE DEUTSCHES ALTENHEIM,  
INCORPORATED PROJECT AT 2222 CENTRE STREET, WEST ROXBURY (BOSTON),  
MASSACHUSETTS. Notice is hereby given that Massachusetts Development Finance Agency  
will hold a public hearing on July 12, 2016 at 3:00 P.M. at 99 High Street, 11<sup>th</sup> Floor, Boston,  
Massachusetts, to consider the issuance of revenue bonds by Massachusetts Development  
Finance Agency in an amount not exceeding \$6,375,000 for the benefit of Deutsches Altenheim,  
Incorporated (the "Borrower" which term includes in this notice any parent, subsidiary, or other  
affiliate thereof). The proceeds of the bonds will be used to finance: (i) the renovation of  
German Centre for Extended Care, an approximately 133-bed skilled nursing facility located at  
2222 Centre Street, Boston (West Roxbury), Massachusetts, now owned, operated or managed  
by the Borrower and used in the Borrower's business of providing nursing, rehabilitation and  
social services; (ii) the acquisition of furnishings, fixtures and equipment for said facility; and  
(iii) the payment of capitalized interest and costs of issuance (collectively, the "Project"). The  
total currently estimated cost of the Project is \$6,375,000. The bonds will not constitute a  
general obligation of, or a pledge of the faith and credit of Massachusetts Development Finance  
Agency or a general obligation of, or a debt or pledge of the faith and credit of The  
Commonwealth of Massachusetts.

Interested persons wishing to express their views on such Project and the proposed  
issuance of revenue bonds to finance and refinance the Project will be given the opportunity to  
do so at the public hearing or may, prior to the time of the public hearing, submit their views in  
writing to Massachusetts Development Finance Agency, 99 High Street, 11<sup>th</sup> Floor, Boston,  
Massachusetts.
