- Leave Logan Airport via Ted Williams Tunnel
- Exit tunnel in to south Boston take a right on Congress Street
- Take a right on D Street and a right on Summer Street
- Take a left in to the Westin Water front (1)
- Leave take a left on Summer Street follow to Bedford St. take a left
- Take a left on Chauncy Street and a right on Delafeyette ave
- Stop at Hyatt Hotel (2) Leave follow Delafeyette Ave To washington St.
- Take a right and a left on West St. and A Left on Tremont St. Follow to Marriott Courtyard (3)
- Leave take a right on Tremont St. and a Right on Charles Street
- Stop at Milner Hotel (4)
- Leave and take a left in to the back of the Raddison Hotel (5)
- Leave take a right on Stuart Street a Left on Charles Street
- Take a left on Park Plaza and a left on Columbus stop at Park Plaza (6). VALLEY SIDE
- Leave Continue on Columbus ave to Dartmouth St. take a right
- Follow to the Fairmont Copley (7)
- Leave take a left on Huntington Ave and pull in to the Westin Copley (8)
- Leave take a left on to Huntington Ave And follow to Belvidere Street
- Take a right follow to the breezway of the Sheraton Hotel (8)
- Leave on to Dalton Street Take a left and pull over to the right, Hilton Back Bay (9)
- Leave follow Dalton Street to Belvidere Street take a left
- Follow to Huntington Ave Take a Right. Stay to Right and U turn on to Huntington East.
- Pull over to the Midtown Hotel (10)
- Leave follow Huntington Ave Stop at the Colinade Hotel (11)
