The Boston City Council's Committee on Public Safety to which was referred, on April 28, 2010 – August 4, 2010 – August 25, 2010 – September 15, 2010 and September 29, 2010 [respectively]:

Docket # 0592 - *Message and order authorizing the Mayor's Office of Emergency Management to accept & expend a grant of \$400,000.00 from the Federal Government under the American Recovery & Reinvestment Act of 2009 for Assurance Planning for the Mayor's Office of Emergency Management.*

Docket # 1076 - *Message and order authorizing the Mayor's Office of Emergency Management to accept & expend a grant of \$11,651,680.00 from DHS, UASI Grant FY 2009 to address the unique, planning, training, exercise, equipment and operational needs of large urban areas.*

Docket #1078 - *Message and order authorizing the City to accept & expend a grant of \$1,400,000.00 from various Government Agencies, including FEMA, as reimbursement for expenses incurred due to storms & flooding in March & April 2010.*

Docket # 1079 - *Message and order authorizing the City to accept & expend a grant of \$1,378,249.00 from DHS for the purpose of catastrophic planning within the designated region, including the Boston Urban Area, Providence Urban Area, Commonwealth of Mass, State of New Hampshire and Rhode Island.*

Docket # 1081 - *Message and order authorizing the Fire Academy to establish in accordance with General Law Ch.44, Sec. 53E1/2 a revolving fund to accept from the fund up to max of \$200,000.00 for purpose of purchasing training equipment, certifying instructors, updating facilities and providing funds for other training needs not otherwise budgeted for.*

Docket # 1145 - *Message and order authorizing the Fire Department to accept & expend a Port Security Program Grant of \$1,180,257.00 from the Commonwealth of Massachusetts – Executive Office of Public Safety & Security for construction of CBRNE Watercraft.*

Docket # 1146 - *Message and order authorizing the Public Health Commission to accept & expend a grant of \$750,000.00 from the U.S. Department of Justice, Office of Justice Programs FY 2009 Discretionary Grant Programs, for the purpose of violence intervention & prevention in the City.*

Docket # 1147 - *Message and order authorizing the Police Commissioner to accept and expend \$300,000.00 of the FY 2010 ICAC Program award, from the Office of Juvenile Justice & Delinquency Prevention, to identify child victims of commercial sexual exploitation, provide services and support for them & investigate & prosecute cases against adults who exploit children and youth.*

Docket # 1224 - *Message and order authorizing the Police Commissioner to accept and expend a grant of \$ 904,932.00 from the U.S. Department of Justice, for the FY 09 Edward Byrne Memorial Justice Assistance Grant funds for supporting crime prevention & law enforcement.*

Docket # 1225 - *Message and order authorizing the Police Commissioner to accept & expend a grant of \$307,967.00 from the U.S. Department of Justice for the FY 2010 Forensic DNA Backlog Reduction Program.*

Docket # 1226 - *Message and order authorizing the Police Commissioner to accept and expend the FY 2010 (VAWA) STOP grant of \$43,560.00 from the Executive Office of Public Safety & Security to support the BPD's Civilian Domestic Violence Advocate.*

Docket # 1351 - *Message and order authorizing the Police Commissioner to accept and expend a grant of \$749,828.00 from the U.S. Department of Justice, Bureau of Justice Assistance funded under the FY 2010 Second Chance Act Prisoner Re-entry Initiative for the purpose of funding the Boston Re-entry Partnership Initiative.*



Docket # 1353 - *Message and order authorizing the Police Commissioner to accept and expand a grant of \$172,574.00 from the FY 2010 Paul Coverdell National Forensic Sciences Improvement Act Formula funded by the National Institute of Justice.*

Docket # 1354 - *Message and order authorizing the Police Commissioner to accept and expend a grant of \$80,000.00 from the Paul Coverdell Forensic Sciences Improvement Grants Program funded by the U.S. Department of Justice, Office of Justice Programs passed through from the Massachusetts State Police.*

Docket # 1355 - *Message and order authorizing the Police Commissioner to accept and expend a grant of \$75,000.00 from the U.S. Department of Justice, for the purpose of supporting law enforcement response to human trafficking.*

Project Overview

The subsequent material outlines the primary goals and objectives set forth by the Mayor's Office of Emergency Management and the Metro Boston's Homeland Security Region's (MBHSR) Jurisdictional Points of Contacts (JPOCs) as the Region collectively moves forward in its regional homeland security planning.

MBSHR partners continue to be actively engaged in meeting the goals and objectives outlined in the updated FFY2009 UASI Strategy. As the MBHSR moves forward into the FFY2009 UASI project period, we continue our commitment to pursuing the goals, objectives, and individual homeland security tasks outlined in the UASI HS Strategy. In accordance with DHS guidance, MBHSR has moved towards an all hazards approach to improving regional preparedness focusing on prevention, preparedness, response and recovery.

All equipment procurements will adhere to DHS's Authorized Equipment List. All training and exercise requests will adhere to the EOPSS Training and Exercise Guidance and all exercises will be compliant with the Homeland Security Exercise and Evaluation Program requirements.

The following eight investments represent the projected FFY2009 UASI regional initiatives throughout the MBHSR:

Investment I: Implement NIMS and the National Response Framework (\$1,825,000)

Investment II: Implement the National Infrastructure Protection Plan (\$1,588,000)

Investment III: Strengthen Information Sharing and Collaboration (\$1,489,000)

Investment IV: Communications Interoperability (\$1,470,000)

Investment V: CBRNE Detection Capability (\$2,639,000)

Investment VI: Medical Surge and Mass Prophylaxis Capabilities (\$500,000)

Investment VII: Planning and Citizen Preparedness Capabilities (\$1,025,000)

Investment VIII: UASI Program Management (\$1,115,680)
