- 0732 Order authorizing the Police Commissioner to accept and expend the FY11 State 911 Department PSAP and Regional Emergency Communication Center Support and Incentive grant of \$2,296,567.00 (Two Million, Two Hundred Ninety Six Thousand, Five Hundred and Sixty Seven Dollars) from the Executive Office of Public Safety and Security State 911 Department.


