FY11 BPS Budget

The Boston City Council's Committee on Ways and Means and Committee on Education will hold joint public hearings on the dates scheduled below regarding the FY11 Boston Public School Budget. The hearings will be held in the Christopher A. Iannella Chamber on the 5th floor of the Boston City Hall.

The subject of these hearings include:

Docket # 0538 - Message and order for Annual Appropriation for the School Department for FY2011.

Docket #0541 - Message and order for a loan of \$37,215,000.00 for repairs to public buildings, including the School Department.

Docket # 0543 - Message and order for a loan of \$32,195,000.00 for computer hardware, software, other data processing equipment, and financial management and accounting systems, for the purposes of city departments, including the School Department.

Docket #0546 - Message and order for a loan of \$11,555,000.00 for the municipal outdoor recreational and athletic facilities, for various city departments, including the School Department.

These matters were sponsored by Mayor Menino and referred to the Committee on Ways & Means on April 14, 2010.

Docket #0685 – Order for a hearing regarding policies in Boston Public Schools.

This matter was sponsored by Councilor Connolly and referred jointly to the Committee on Ways & Means and Committee on Education on May 5, 2010.




