Chamber Music America is dedicated to promoting artistic excellence and economic stability within the chamber music profession, and to ensure that chamber music, in its broadest sense, is a vital part of American life. To that end, Chamber Music America provides services, resources, membership benefits, and grant opportunities to jazz artists. Through the organization's the New Works: Creation and Presentation Grant Program, a component of the Doris Duke Jazz Ensembles Project, Chamber Music America supports composer and performer-led ensembles for the creation and presentation of original jazz music. Ensembles must consist of a core of musicians who perform original music that includes jazz improvisation, have a demonstrated history of performing together as a jazz ensemble, and range in size from two to ten members. Grants fund a commission fee and ensemble honorarium. In addition, funds are available to grantees for conducting community-based audience engagement projects.

Facilities Initiative

Parents United for Child Care and the Child Care Capital Investment Fund

Program:

Parents United for Child Care has partnered with the Child Care Capital Investment Fund to conduct a seventh round of facilities funding for Boston school-age providers. The Facilities Initiative was developed in 1997, with four primary goals:

- To improve the physical environment of Boston's out-of-school time programs;
- To increase the supply of Boston's out-of-school time child care programs;
- To train and assist out-of-school time providers in designing and implementing physical improvements to enhance program delivery and program quality; and
- To leverage additional resources including low interest loans, grant monies and institutional commitments to expand and improve out-of-school time program facilities.

In the current round, the initiative will award funding in two areas:

- Capital Improvement Grants these grants are awarded for facilities improvement, expansion, or start-up projects. Loan funds are also available.
- Planning Grants these smaller grants are awarded to help providers develop a plan for their facilities projects.

Along with the grant funding, each grantee is paired with a Quality Advisor who offers

technical assistance to the program.

Summer Fund

Program:

The Summer Fund is a donor collaborative that generates resources to support and strengthen summer camps serving the low-income neighborhoods of Boston, Cambridge, Chelsea, and Somerville. Through the Summer Fund process, Associated Grant Makers serves as a broker between community agencies administering summer camps and the corporate, foundation, and individual donors who offer financial support to these camps. The Fund contributes to quality summer camps that provide youth with opportunities for skill development, personal growth, and new experiences.

The Summer Fund provides funding in four categories.

- General Camp Operating Support: Helping Kids Learn, Grow, and Have Fun The Summer Fund provides camps with funding that can be used for general operating expenses.
- 2) The Educational Initiative: Giving Kids An Academic Boost Through training and educational resources specifically designed for staff working with urban youth, camps are more prepared to provide services that address the whole child while building their educational programming.
- 3) Cultural Day: Providing Kids with Cultural Experiences The Cultural Day program supports free admissions during the summer for campers to eight leading Boston area cultural and educational programs, as well as reduced cost admissions to 27 other organizations, including the Franklin Park Zoo, the USS Constitution, museums, dance workshops, and theater productions.
- 4) Homeless Campership Fund: Getting Homeless Kids to Camp The Homeless Campership Fund offers subsidies to camps that provide access to homeless children living in shelters.

The Summer Fund provides camps with funding that can be used for general operating expenses, not capital improvements. Recommendations are based on the camp's proposal, request, final report, site visit evaluations, and the anticipated funds available through the 2004 Summer Fund. First-time applicants are eligible to apply for a

maximum of \$5,000, while camps that have been funded for a year or more may apply

for up to 40 percent of their cash budget.
