Subject of the hearing will be applications for Certificates of Appropriateness on the agenda below, review of architectural violations, and such business as may come before the commission, in accordance with Ch. 616 of the Acts of 1955, as amended. Applications are available for public inspection during business hours at the offices of the Environment Department. Applicants or their representatives are advised to attend, unless indicated otherwise below. Sign language interpreters are available upon request.

Proposed Work: Modifying the paint color for the faux brick panels; installing rooftop mechanical equipment with screens, modifying the elevator bulkhead; and installing

a mechanical louver and boiler vents on the Ridgeway Lane façade.

be consistent with the project description given below.) Commission staff will accordingly authorize the execution of the work, attaching any applicable provisos, reflecting the relevant guidelines and precedents.

▶ PLEASE NOTE THAT NO FURTHER CORRESPONDENCE WILL BE ISSUED for the applications listed below. The electronic building-permit application as annotated by commission staff will constitute your Certificate of Appropriateness; this will be valid for two years from the date of the hearing. The applicant is required to notify the commission of any project changes; failure to do so may affect the status of the approval.

Application 16.1591 BH	81 Beacon Street: Repoint.
Application 16.1602 BH	51 Branch Street: Repaint front façade off-white to match existing.
Application 16.1585 BH	1 Chestnut Street: Repaint the front door and gate door at 21 Walnut Street black to match existing; and replace the hinge in-kind at the gate door.
Application 16.1595 BH	23 Chestnut Street: Repaint the front façade, lintels, sills, front door, entryway, windows, shutters, garden fence and balustrade at the parlor floor to match existing

Application 16.1352 BH	79 Chestnut Street: Remove the two AC units from the first floor transoms and install multi-light wood transom windows and replace three single-light fixed wood display windows all with a black painted finish to match the historic in terms of configuration, operation, material, details and finish; repaint all of the ground floor infill black to match existing; repaint the second and third floor windows off-white to match existing; and repair the window screens at the second and third floors.
Application 16.1449 BH	101 Chestnut Street: Remove the non-historic gooseneck light fixtures and exposed conduit at both the main and secondary entryways, and installing two light fixtures with a black finish and concealed conduit flanking both entryways.
Application 16.1507 BH	11 Irving Street: Install a wrought iron handrail with a black painted finish on the left wall of the recessed garden level entryway.
