ADMINISTRATIVE REVIEW

In order to expedite the review process, the Commission has delegated the approval of certain work items, such as those involving ordinary maintenance and repair, restoration or replacement, or which otherwise have a minimal impact on a building's appearance, to the staff pending ratification at its monthly public hearing. The following applications have been identified as being eligible for such approval.

► Applicants listed under this heading **NEED NOT APPEAR** at the hearing. Following the hearing, please present a copy of this agenda at the Inspectional Services Department (1010 Massachusetts Avenue) when applying for permits. ISD personnel will send an electronic copy of your building-permit application to the Environment Department. (To avoid confusion, the text of your building-permit application should be consistent with the project description given below.) Upon its receipt, Commission staff will accordingly authorize the execution of the work, attaching any applicable provisos, reflecting the relevant guidelines and precedents.

PLEASE NOTE THAT NO FURTHER CORRESPONDENCE WILL BE ISSUED for the applications listed below: the electronic building-permit application as annotated by Commission staff will constitute your Certificate of Appropriateness. The applicant is required to notify the commission of any project changes; failure to do so may affect the status of the approval.

15.991 SE: 76 Chandler Street: Replace flat roof; reconstruct roof deck (**visibility must be reviewed by staff**).

15.980 SE: 474 Columbus Avenue: Repoint masonry; repair and repaint sills and lintels (must match original brownstone color); replace 13 windows (wood); repaint metal-clad oriel (HC-76/77).

15.987 SE: 34 Dartmouth Street: Repair/rebuild chimney.

15.981 SE: 7 Dwight Street: Replace 3 windows (aluminum clad).

15.986 SE: 60 East Springfield Street: Installation of a blade sign and a halo-lit sign at entry.

15.994 SE: 11 ½ Greenwich Park: Repair existing wood windows and install black storm windows; repair and repoint masonry, as required; repair wood cornice; install new copper gutters and downspouts; repair and restore all brownstone ornament, as required; restore entry doors and transom; repair and repaint security grates at garden level windows; repair existing iron railings and fence; reopen existing light well and restore existing wood window; modify and repair existing roof deck (**visibility must be reviewed by staff**).

15.989 SE: 411 Massachusetts Avenue: Construct a roof deck (**visibility must be reviewed by staff**).

15.996 SE: 705-723 Tremont Street: Replace, augment, and reconfigure telecommunications equipment at roof.

15.984 SE: 6 Union Park: Replace 14 windows (wood) and associated deteriorated wood window trim.

15.950 SE: 20 Upton Street: Repoint masonry; repair sills and lintels & repaint (must match original brownstone color); replace deteriorated wood trim at windows.

15.993 SE: 28 Upton Street: Replace asphalt shingles at mansard; replace flat rubber roofs including copper edge detail; install new copper gutter.

15.988 SE: 30 Upton Street: Replace deteriorated gutter and wood trim.

15.985 SE: 35 Upton Street: Repoint masonry.

15.990 SE: 148 West Concord Street: Construct a roof deck (**visibility must be reviewed by staff**).

15.979 SE: 148 West Concord Street: Replace 14 windows (wood); repair deteriorated sandstone sills, lintels, and door surround.

15.983 SE: 116 West Newton Street: Replace 3 windows (wood).
