## **ADMINISTRATIVE REVIEW**

In order to expedite the review process, the Commission has delegated the approval of certain work items, such as those involving ordinary maintenance and repair, restoration or replacement, or which otherwise have a minimal impact on a building's appearance, to

the staff pending ratification at its monthly public hearing. Having been identified as meeting these eligibility criteria and all applicable guidelines, the following applications will be approved at this hearing:

▶ Applicants listed under this heading <u>NEED NOT APPEAR</u> at the hearing. Following the hearing, please present a copy of this agenda at the Inspectional Services Department (1010 Massachusetts Avenue) when applying for permits. ISD personnel will send an electronic copy of your building-permit application to the Environment Department. (To avoid confusion, the text of your building-permit application should be consistent with the project description given below.) Upon its receipt, Commission staff will accordingly authorize the execution of the work, attaching any applicable provisos, reflecting the relevant guidelines and precedents.

<u>PLEASE NOTE THAT NO FURTHER CORRESPONDENCE WILL BE ISSUED</u> for the applications listed below: the electronic building-permit application as annotated by Commission staff will constitute your Certificate of Appropriateness. The applicant is required to notify the commission of any project changes; failure to do so may affect the status of the approval.

- 16.1322 SE: 6 Bond Street: Replace two front windows in kind with aluminum clad wood windows.
- 16.1321 SE: 548 Columbus Avenue: Replace front brownstone staircase in kind.
- 16.1342 SE: 600 Harrison Avenue: Install exterior sign at canopy above main entrance.
- 16.1326 SE: 12.5 Lawrence Street: Repair slate roof with existing materials. Replace rotted wood sills in kind.
- 16.1328 SE: 141 Pembroke Street: Replacement of existing rubber roof in kind and application of new metal flashing.
- 16.1335 SE: 328 Shawmut Avenue: Replace shingles on sides of back dormers with slate-like shingles.
- 16.1336 SE: 330 Shawmut Avenue: Replace shingles on sides of back dormers with slate-like shingles.
- 16.1337 SE: 334 Shawmut Avenue: Replace shingles on sides of back dormers with slate-like shingles.
- 16.1331 SE: 643 Tremont Street: Install new blade sign and bracket.
- 16.1316 SE: 655 Tremont Street: Install new signage on the signband and a new blade sign on an existing bracket.

- 16.1332 SE: 205 West Newton Street: Replace 2 2/2 wood windows in kind.
- **16.1334 SE: 4 Worcester Square:** Replace 1 dormer window with a 2/2 wood window and three windows in a bay with 1 2/2 wood window in the middle and 2 1/1 windows on either side.
- **16.1409 SE: 26 Worcester Square**: Replace circular gutter at base of mansard in kind. Replace 2 downspouts in kind. Repoint damaged front façade joints. Repair faschia and soffit with in kind materials, reroof flat strip below mansard in kind.
