Upon its receipt, Commission staff will accordingly authorize the execution of the work, attaching any applicable provisos, reflecting the relevant guidelines and precedents.

**PLEASE NOTE THAT NO FURTHER CORRESPONDENCE WILL BE ISSUED** for the applications listed below: the electronic building-permit application as annotated by Commission staff will constitute your Certificate of Appropriateness. The applicant is required to notify the commission of any project changes; failure to do so may affect the status of the approval.

**15.426 SE: 17 Braddock Park:** Replace 2 windows (wood).

**15.448 SE: 509 Columbus Avenue:** Install signage.

**15.437 SE: 621 Columbus Avenue:** Repoint masonry at 7 penthouses.

**15.439 SE: 14 Concord Square:** Replace 4 windows (aluminum clad).

**15.424 SE: 24 Dartmouth Street:** Restore front entry stoop; repaint stoop and garden wall with HC-69.

**15.449 SE: 41 East Concord Street:** Repair/restore 2 historic wood windows; install 2 storm windows.

**15.443 SE: 55 East Springfield Street:** Replace 10 windows (aluminum clad).

**15.442 SE: 34 Hanson Street:** Replace 11 windows (aluminum clad).

**15.462 SE: 411 Massachusetts Avenue:** Masonry repair/repainting; repair/in-kind replacement of deteriorated wood trim at dormers/window openings; repair copper gutter and downspout; restore historic wood windows on the front façade and at the rear bay; replace 4 dormer level windows on front façade (2 larger windows must be 2/2 configuration; all 4 must be wood on the exterior); replace 7 windows at rear (2/2, aluminum clad).

**15.423 SE: 702 Massachusetts Avenue:** In-kind replacement of copper gutter; spot masonry repointing at sills and lintels; fire escape repairs.

**15.444 SE: 25 Milford Street:** Repair and repoint wood entry doors.

**15.438 SE: 30 Rutland Square:** Replace flat rubber roof and associated edge flashing; replace existing roof deck (**visibility must be reviewed by staff**).

**15.447 SE: 43 Rutland Square:** Replace flat rubber roof and associated edge flashing.

**15.441 SE: 54 Rutland Square:** Replace 3 windows (wood).

**15.425 SE: 289 Shawmut Avenue:** Replace 3 windows (wood).

**15.427 SE: 314 Shawmut Avenue:** Replace 7 windows (wood)

**15.466 SE: 462 Shawmut Avenue** Replace 8 windows (wood, 2/2 configuration); replace asphalt shingle roof.

**15.463 SE: 21 Upton Street #1:** Replace 2 windows (wood).

**15.464 SE: 21 Upton Street #2:** Replace 5 windows (wood).

**15.440 SE: 149 West Canton Street:** Masonry repointing at cheek walls of front entry stoop; repair/repaint front entry stoop with HC-69.

**15.397 SE: 215 West Canton Street:** Replace and enlarge existing roof deck (**visibility has been reviewed by staff**).

**15.400 SE: 217 West Canton Street:** Construct a roof deck (**visibility has been reviewed by staff**).

**15.436 SE: 229 West Canton Street:** Replace flat rubber roof and associated copper flashing; replace existing roof deck (**visibility has been reviewed by staff**).

**15.446 SE: 135 West Concord Street:** In-kind replacement of slate roof.

**15.445 SE: 145 West Concord Street:** Repoint masonry.

**15.430 SE: 117 West Newton Street:** Replace 5 windows (wood).

**15.435 SE: 217 West Newton Street:** Masonry repairs/repainting.

**15.403 SE: 22 Worcester Square:** Construct a roof deck (**visibility has been reviewed by staff**).
